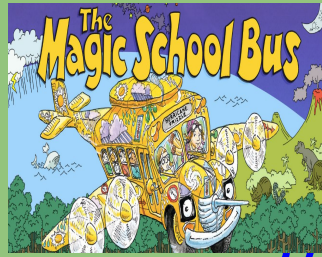

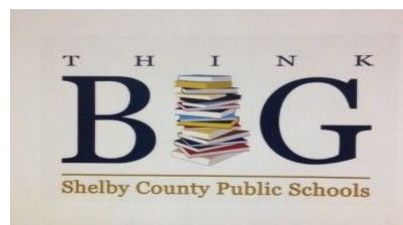

Medical Release
